#### Hello, Aaniin, Bonjour

On behalf of the Kawartha-Haliburton Children's Aid Society, we are pleased to present the 2021/2022 Annual Report that represents another extraordinary year delivering responsive services in support of child safety and well-being.

Throughout the year, primary focus was placed on the pandemic by responding to the changing public health guidelines and meeting the increasing needs for children, youth and families. The impact after two (2) years navigating the pandemic has been significant for everyone in our community, including our employees. Yet the employee group was a continued source of strength for the Agency. Through their resilience, conviction and leadership, employees provided a sense of stability and support for the most vulnerable people in our communities. Employees carried out critical child welfare duties to ensure child safety; putting the needs of children, youth and families first that was guided by our vision, mission and values. Similar to last year, it was not business as usual and was a year of continued uncertainty for everyone.

With the launch of a new Strategic Plan in 2020/21, the Agency entered year two (2) of the three (3) year plan with commitment and renewed focus on advancing many of the priorities identified to provide necessary supports to families, reduce admission of children to care by focusing on natural connections with family and community, integrating diversity, equity and inclusion principles into our work and supporting staff, volunteers and resource caregivers. Staff, volunteers and resource caregivers are truly our greatest strength and ensuring supports and engagement remain priorities, particularly as we continue to navigate the complexities presented throughout the pandemic and beyond.

The Agency commenced the implementation plan for introducing Signs of Safety as the core practice framework that will centre the

voices of children, youth, families and community supports to enhance child safety as well as respecting and valuing cultural heritage and lived experience. Embedding equity into our practice was also a focal point for both the Agency and Board of Directors. Through continued dialogue, critical reflection and training for employees and leaders, the Agency has established an anti-racism policy, implemented case conferencing and updated human resources systems to enhance hiring practices. It is our commitment to deliver equitable services to our community and employee group and we know that there are many areas where we can continue to improve upon.

This year also represented the final year of transitioning families to Dnaagdawenmag Binnoojiiyag Child and Family Services as part of our ongoing commitment to restoring the mandate of child welfare back to Indigenous communities. We are humbled by the experience and learning we have had through this transition as we remain committed in our work towards Truth and Reconciliation and the nine sector commitments. Our work to enhance service delivery for/with Curve Lake First Nation remains a priority as we work together to ensure child welfare services are delivered in a responsive way that respects and at all times considers traditions, culture, language, values and lifestyle.

As part of a large community that serves children, youth and families we cannot work in isolation. We extend our sincere thanks and appreciation to all of our community partners for their collaboration and support in ensuring child safety. To the Kawartha-Haliburton Children's Foundation, we can't thank you enough for the financial support provided to children, youth and families when they need it the most. To the Board of Directors, who give endless support to fulfilling the mandate of the Agency, through your wisdom, direction, advocacy and support, we thank you. Last, but certainly not least, to the employees, leaders, volunteers and resource caregivers, you truly are our greatest strength. Your endless support, compassion and commitment makes a difference for children, youth and families each and every day.

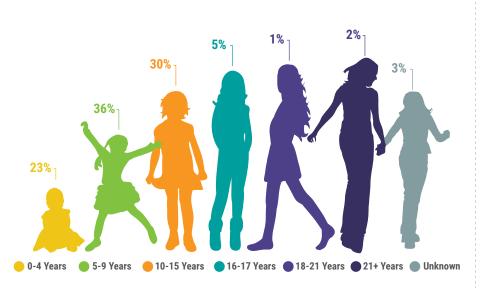

5,228 children and youth were served in 2021-2022. Each child is counted only once in the age category they were on April 1st, 2022.



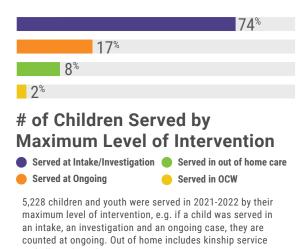
