The Director of Services is responsible for the provision of leadership that results in the delivery of excellent client focused services in accordance with the Child, Youth and Family Services Act, 2017 (CYFSA) and other applicable provincial and federal legislation.

The Director ensures services are responsive, evidence-informed, culturally safe, grounded in principles of equity, anti-oppression, and reconciliation. This role supports the development, implementation, and evaluation of policies and service delivery models aligned with the Agency's strategic plan, mission, values, and ensures decisions are informed by data analytics and the lived experiences of the children, youth, and families served.

As a member of the Senior Leadership Team, the Director contributes to annual service planning, budget development, ongoing processes to align service delivery and spending, organizational risk management, and provides clinical leadership rooted in the Agency's equity-focused philosophy and values. The Director provides supervision to service delivery senior managers.
