POSITION SUMMARY:

Reporting to the Executive Director, the Director of Services is accountable for the strategic and service leadership of Kawartha Haliburton Children's Aid Society. The incumbent will work primarily from the Peterborough offices. Initially the incumbent will be available in offices with the opportunity for a hybrid work arrangement available after completion of probation, in keeping with agency practices and coordinating with other senior staff.

The Director of Services is responsible for the provision of leadership that results in the delivery of excellent client focused services in accordance with the Child, Youth and Family Services Act, 2017 (CYFSA) and other applicable provincial and federal legislation. The Director ensures services are responsive, evidence-informed, culturally safe, grounded in principles of equity, anti-oppression, and reconciliation. This role supports the development, implementation, and evaluation of policies and service delivery models aligned with the Agency's strategic plan, mission, values, and ensures decisions are informed by data analytics and the lived experiences of the children, youth, and families served.

As a member of the Senior Leadership Team, the Director of Services contributes to annual service planning, budget development, ongoing processes to align service delivery and spending, organizational risk management, and provides clinical leadership rooted in the Agency's equity-

focused philosophy and values. The Director provides supervision to service delivery senior managers and engages with community partners to ensure collaborative service delivery.

- Demonstrates analytical skills to accurately assess and evaluate the impact of decisions, policies and strategies, and to make informed management decisions and recommendations to the Executive Director.
